Falcon Chapter will host 2016 State Convention July 14-16 at Lexington Hotel in Jacksonville

The Falcon Chapter 399 will be holding the Air Force Association Florida Convention at the Lexington Hotel Riverwalk in Jacksonville on the beautiful St. Johns River on July 14, 15 and 16.

The convention will be an opportunity to share a vision of the future of the AFA in Florida, prescribe antidotes to a general decline in membership and seek new volunteers for leadership positions.

"I am going to propose at the state convention that we recommend we close the Evenson, McCarthy and Highlands Chapters. If I do that, I will have to propose how those members will be divided up among the remaining chapters," Florida AFA President Bill Yucuis said. (See Bill's column on page 2.)

For early bird arrivals for the convention, there will be a free wine tasting at the Peninsular Condominiums located on the St. Johns River just a short walk down the Riverwalk from the Lexington, according to Bruce A. Fouraker, Falcon Chapter convention chairman.

The convention host chapter will have wine and cheese available for the members who decide to check in on Thursday and spend an extra day in Jacksonville.

On Friday, members of the AFA attending the convention will take a short walk down to the Riverwalk next to the hotel where a cruise boat and dinner will be served.

Breakfast vouchers are included in the cost of the room, and after breakfast on Saturday, the business meeting will start. Midday lunch will include the recognition of the state's top CyberPatriot teams and a speech by a leading politician, business person or military expert.

While the afternoon business session in taking place, spouses of those in session can attend a fashion show put on by the Petunia Patch. This leads up to dinner and more awards as well as the keynote speaker. The weekend will wind down with casual conversation in the hospitality suite after the awards dinner.

The convention will be packed with fun activities and a good time should be had by all.

The deadline for registering was June 10, and the convention hosts cannot guarantee the availability of hotel rooms for reservations received after this date. By directly paying the chapter, participating members could save room and sales taxes totaling 13 percent. Room rates include two breakfast tickets and free self-parking.

I have been an AFA Life Member since I was a first lieutenant and flying F-4s, which means that was a long time ago. I joined primarily for the life insurance benefits and I liked the Air Force Magazine. After retiring in 1994, I moved to Orlando and began a teaching career. In 2002, I was hired to develop a four-year high school aerospace engineering track for a district Engineering Magnet Program. Like most education initiatives, there was little money to accomplish this task and I remembered the Air Force Association had educator grants, so I applied and

received it. The Central Florida Chapter VP for Aerospace Education at the time was Richard Ortega. For those of you who never had the privilege of knowing Richard, he was the Energizer Bunny of AFA recruitment and personally recruited more AFA members than anyone I have ever met. Richard would invite every AFA grant winner to



attend a chapter meeting so I went to my first chapter meeting. I attended a few more and soon Richard drew me into helping out with AFA education programs. The point of this little story is I would have never gotten involved with AFA without the individual initiative of one person. The only way AFA can solve the current membership decline is for individuals, myself included, to take the initiative and ask one person to join or renew with AFA. Then ask that individual to do one small thing with the chapter and encourage them to find a "niche" in AFA where they can use their talents to improve AFA and the country.

I attended my first AFA National Convention about 12 years ago. It wasn't until I attended a couple of National Conventions that I began to understand the impact and importance of AFA, both nationally and locally. It is one of the reasons Florida took the initiative two years ago to encourage more chapter members to attend their first national convention. Florida had already reimbursed all Florida delegates \$100 but now for first-time attendees, Florida will reimburse the member an additional \$400. It is also why Florida has been a leader in submitting candidates for the AFA Emerging Leaders Program, where members learn about AFA National by being a member of a National Committee and interacting personally with AFA national leaders.

When I attended my first national convention, AFA was in the midst of changing the entire organizational structure. At the time, I didn't know the old structure so I could only sit back and listen while AFA members debated and discussed the pros and cons of changing from a

Veteran's organization to an Education non-profit. It was a tumultuous couple of conventions before it was finally approved. At the Region Presidents meeting in May, Scott Van Cleef, AFA Chairman of the Board, asked the Region Presidents if it might be time to reexamine the AFA structure again and see if there is a better way of doing business. Because this would be a multi-year arduous task, Scott asked us to go poll the AFA states and chapters to see if they felt such an endeavor should be undertaken. We will discuss this at the State Convention in July. I

personally think it is time to discuss it.

These presidents were dedicated AFA members doing the best they could to keep AFA relevant in

their respective regions but had become "President for Life." The "active" chapter membership in these chapters had been dwindling to the point where there was no plan for replacing this one individual should they relinquish their post. The solution is Leadership Development, which is nebulous term and not easy to define. Of course, this is tied directly to membership because if new members are not recruited, there generally is no way to develop new leaders. This is also occurring at the state level to some extent. Ernie Webster has been State Treasurer for nine years and it is time for a replacement. It has been an arduous task to find a candidate to take on these responsibilities but I am pleased to announce that Gary Lehmann has agreed to run for State Treasurer. The State Leadership Development plan is for me to be State President for another year and Sharon Branch to be State Vice President next year and then become State President after me. Susan Ault-Davis has agreed to be State Secretary another year also. I hope to leave this year's State Convention with a plan for the two years after that. That means we need to identify the next State President candidate after Sharon and the next State Secretary after Susan. Let's not wait until the last minute to beg people to move into these positions. The same goes for Emerging Leaders. Chapters should begin looking for potential candidates for 2017 and beyond. The Florida Region can recommend two candidates each year. It is an opportunity for AFA Florida members to find out what AFA is all about.

Convention that we recommend we close the Evenson, McCarthy, and Highlands Chapters. If I do that, I will have to propose how those members will be divided up among the remaining chapters. Given the size of these chapters, there is no easy solution to this. Every chapter needs to realize they will probably be "assigned" new members which we all know cannot be adequately serviced, but there is no provision for "Member-At-Large." This, by the way, was one of the discussion items at the Region Presidents meeting. Namely, maybe AFA needs to have some provisions for "virtual" members not tied to a geographic area because they cannot personally attend local chapter meetings. Already, most chapters have such a large geographic area that only a "core" area provides the

majority of active Chapter members.

Let me end on a more positive note (I think). Florida has some of the most active and accomplished chapters in AFA. That is why Florida has been recognized numerous times as the Best State organization in AFA. The articles in this Spirit show some of their great accomplishments done throughout Florida. Every chapter has its own unique character and talents and they need to continue to build on those. In an ideal world, every chapter would have enough active members to work all the areas of AFA, such Power Advocate, Membership, Education, Government Affairs, Veterans Affairs, and many more. I only ask chapter leaders to continue the great work you do but look to the future. Where will AFA Florida be five years from now? 10 years? I hope Florida will continue to be recognized as the Best State organization in AFA. That can't happen by what I do but what all of us do together.

Florida AFA Teacher of the Year "Turns Heads"

Dr. Suzanne Halverson, the 2016 Central Florida Chapter AFA Teacher of the Year, is the Florida AFA Teacher of the Year and has been submitted to the Air Force Association for the national Teacher of the Year Award.

Dr. Halverson teaches at Polk State Chain of Lakes Collegiate High School. Her junior and senior classes include science, technology, engineering and math (STEM) research, medical terminology, and honors anatomy and physiology.

A dynamic teacher, Dr. Halverson aligned the curriculum at her school with national standards to strengthen the STEM program. This helped students realize the real-world applications of STEM as they decide on their future careers. Among these are two key career paths with rapidly increasing potential: bioengineering and robotics.

Dr. Halverson recently guided her students as they built an open remotely operated vehicle underwater exploration robot. They even used a 3D printer to manufacture parts of the robot. The students conducted research as a part of underwater explorations, and produced a student documentary video which will compete in the 2016 Blue Ocean Film Festival and Conservation Summit in St. Petersburg. These same students will also compete in the Marine Advanced Technology Education International Underwater Robotic Engineering Competition.

With the help of the Robotic Assisted Microsurgical Endoscopy Society (RAMSES), Dr. Halverson developed a Scholarobotic Academy. Her students also participated in a research project at a robotics institute in the operating room using a current medical robotic system. Fifteen of her students recently traveled to Strasbourg, France to present their perspectives to the RAMSES conference.

Dr. Halverson employs cooperative learning techniques in the classroom which ensure engagement and "buy-in" from her students. They are challenged by both her assignments and assessments. These encourage key learning skills including creativity, clinical

critical thinking, writing, and drawing. Students in the honors anatomy and physiology courses are taught at college level.

Dr. Halverson guides students in medical competitions, contests and challenges, science and engineering fairs, etc. Her knowledge is in demand as she is often asked to judge many events. Also, she often is asked to make presentations at professional conferences directed toward enhancement of education programs offered to students preparing for STEM careers and collegiate success. These presentations were also included in the workforce education center expo.

as the number 2 team in the Southeast Region, which was the highest ranked Florida Open Division team.

AFA Florida extends its congratulations to all of the CyberPatriot VIII national finalists on their incredible performance at the national finals competition in Baltimore on April 11-13.

The 12 Open Division and thirteen All Service Division National Finalist teams competed within in their divisions in the Network Security Master Challenge (with the AT&T Mobile

Device Component), the Cisco Networking Challenge, the Leidos Digital Forensics Challenge, and the Facebook Challenge. The three Middle School Division teams, meanwhile, went head-to-head in the Network Security Master Challenge and the Cisco Networking Challenge.

The *Netrunners* and *CyberBears* will be recognized at the Florida State Convention on July 16 as the top Florida Cyber Patriot teams in their respective divisions.

The Sarasota-Manatee Chapter of the Air Force Association hosted a showing of the movie "Lone Survivor" on April 9 at the Regal Hollywood 20 Theater in downtown Sarasota.

Thanks to the generosity of the Regal Cinema, the chapter was able to offer the showing free of charge to veterans of all services in two-county area. Approximately 50 – 60 chapter members, veterans and guests attended.

Taken from a *The New York Times* bestseller, this story of heroism, courage and survival is based on a true incident. It tells the story Marcus Luttrell, a part of a four-man Navy SEAL team who were sent on Operation Redwing, an ill-fated covert mission in late June 2005. Tasked to capture or kill notorious Taliban leader Ahmad Shah in the Hindu Kush region of Afghanistan, Marcus and his team are left to fight for their lives when they are discovered by local shepherds.

Luttrell was the only survivor of an extraordinary firefight that produced the largest loss of life in American Navy SEAL history. His squad mates fought valiantly beside him until he was the only one left, blasted by an RPG into a place where his pursuers could not find him. Over the next four days, terribly injured and presumed dead, Luttrell crawled for miles through the mountains and was taken in by sympathetic villagers who risked their lives to keep him safe from surrounding Taliban warriors until he was rescued by friendly forces.

A post-movie presentation focused on Air Force Special Operations and featured Brig. Gen. Gwyn Armfield and CMSgt. (Select) Brad Reilly. General Armfield is currently the vice director for Strategy, Plans and Pro-

grams for U.S. Central Command at MacDill AFB. He is also the senior Special Operation officer on the CENT-COM Staff. Chief Reilly is the director of the Joint Special Operations Forces Senior Enlisted Academy, also at MacDill AFB.

Chief Reilly had a special connection to the film as he had met the four Navy Seals depicted in the movie. Approximately two months prior to the event featured in the movie, the Seals were part of a team that responded to assist a unit, in-

cluding then-Sergeant Reilly, that was engaged in a heavy fire fight with Taliban forces.

Attendees were invited to join a no-host lunch at the nearby Sal's New York Deli following the movie.

The chapter expressed thanks to chapter member Sandy Schlitt who conceived the movie imitative and who worked to make it happen.

Eglin and Hurlburt Support Air Force Wounded Warrior Adaptive Sports Camps

For the second year in a row, the Air Force Wounded Warriors (AFW2) held an Adaptive Sports Camp in the Florida Panhandle. Both years, the Eglin Chapter (365) was asked to support it and this year, the Hurlburt Chapter (398) joined in to provide support. These camps are held around the country at no cost to our Wounded Airmen to foster teamwork, community, leadership, and a sense of mission during various stages of recovery. These camps, and the selection process leading up to the annual Warrior Games, are transformative for the airmen and their families, and AFA's Wounded Airman Program provides major support.

The camp was held for five days from 4-8 April and supports two categories of Wounded Airmen. The first category is "Warrior Care" for potential new athletes to come and see what events are available and try ones out which interest them. The second category involves Wounded Airmen selected to represent the Air Force in the Wounded Warrior Games in June. These camps enable them to practice and their training is amazing to be a part of and observe! The camps included a total of 160 people, with 30 caregivers plus an additional 75 volunteers each day, or about 200 a day.

This intense 7:30 a.m. to 4:30 p.m. training was for a total of five days. The two Chapters worked alongside the 96th Force Support Squadron Fitness staff at Eglin and the 1st Force Support Squadron at Hurlburt Field to provide supplemental resources. Both Eglin and Hurlburt Chapters were able to supply healthy snacks and drinks, homemade cookies, pizza and soda, plus support an

Cape Canaveral Chapter 309 of the Air Force Association organized and led the activities that resulted in eight local Florida authors displaying their recently written books.


The event was an unqualified success for the former military authors and two military spouses and covered both fictional and non-fiction topics.

ARLINGTON, Va. (June 1) – The Air Force Association's CyberPatriot program closed registration for its AFA CyberCamp Summer 2016 with a record number of camps scheduled. AFA CyberCamps will be held at 85 locations throughout the nation, reflecting a more than 220% growth from the previous year.

Featured camps include one to be hosted at Texas Women's University, which hosted the first-ever AFA CyberCamp session in June 2014. Additionally, the CyberPatriot Program Office staff will travel to Menlo, California to work with Facebook, a CyberPatriot Silver Sponsor, to host a CyberCamp at the social media giant's headquarters.

AFA CyberCamps were conceived to supplement CyberPatriot's National Youth Cyber Defense Competition, which runs annually from October to March, and to allow educational institutions to engage students in cybersecurity education throughout the year. The AFA CyberCamp curriculum is designed to instruct novice students to learn about cyber ethics, online safety, and the fundamental principles of cybersecurity. AFA's CyberCamp kit consists of instruction modules, demonstration software, and competition software. During these hands-on camps, students will learn important skills in cybersecurity, protecting a network, identifying potential threats, making systems more secure, and protecting themselves on the Internet.

There are no age restrictions on the student participants in the CyberCamp program, but given the curriculum's targeted level of instruction, AFA's CyberPatriot Program Office recommends camps recruit local 7th -12th grade students with little to no previous exposure to cybersecurity.


